

Housing Exemption Request

Waldorf University requires all students to reside on campus as part of our three-year residency requirement and a four-year residency requirement for certain scholarships. If you are eligible and requesting permission to reside off campus, you must complete and submit this form to the Office of Student Life by July 1 for fall semester and December 1 for spring semester. You may be required to meet with the Dean of Students and provide additional documentation before your request can be considered. Misrepresentation of information provided on this form or other documentation may result in the rescission of a granted exemption, and you will still be required to reside in campus housing.

Please note that moving off-campus will decrease your financial aid and room & board grant. We highly recommend that you consult with Financial Aid to determine how your residency status will affect your financial aid package.

In addition, your scholarship may require that you live on campus. Please check with Financial Aid to determine your eligibility. Some scholarships including Pillars require students to live on campus all four years.

If you signed a year-long housing agreement and as an eligible student request to break the housing agreement and move off campus spring semester, a \$250 penalty will be applied to your student account.
